Whereas the Indraprastha Sehkari Bank Ltd is registered at Sl. No-813B/ (Bank) with this Department under the provisions of DCS Act/Rules and Bye-Laws of the Bank.

Whereas the last election of the Managing Committee of the Indraprastha Sehkari Bank Ltd was held on 04.09.2011. The terms of office of the elected members of the committee shall be three year as per provisions of Section 35(3) of the DCS Act 2003.
