**ORDER**

This order shall dispose off the appeal dated 23.09.15 received on 29.09.15 filed by Shri A. K. Garg, Appellant against reference ID No. 1035 dated 12.08.15 U/s 19 of the Right to Information Act, 2005. Consequent upon change of Section vide order dated 11.01.16, this case has been transferred by DR-III on 19.01.16. Shri A. K. Garg, Appellant was not present during the hearing on 02.02.16.

Appellant in his appeal dated 29.09.15 has stated that PIO/Assit. Registrar (Section-II) in his reply dated 25.08.2015 has neither enclosed copy of registration certificate of Eligible CGHS Ltd, nor advised the requisite fee to be deposited with RTI Cell of this office, the information sought in para 2 has not been provided by the Audit Branch, for reply to information in para 3, 4 & 5 the appellant is neither member nor creditor of the society required for seeking information from the society under section 139 of the DCS Act and in last the PIO has not advised the action taken under section 35 of the DCS Act, so far against the society.

On perusal of this case, it is noticed that PIO/AR (Section-II) has already responded to the appellant on 25.08.2015. PIO Section-II is hereby directed to inform the appellant about number of pages and the requisite fee to be deposited in RTI Cell for information at S.No.1 and also to give point wise information, if available in office records in respect of informations sought on point No. 3, 4, 5 and 6 within fifteen days of issue of this order.

PIO/AR (Audit) is hereby directed to give certified copies of annul accounts filed by Eligible CGHS Ltd. from financial year 2009-10 to 2014-15 within fifteen days of issue of this order. (Copy of RTI application dated 03.08.15 enclosed.)

The appeal is disposed off accordingly.

As per Section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, August Kranti Bhawan, Bhikaji Kama Place, New Delhi.
