ORDER

This order shall dispose of 20 appeals filed by Mr. Sunil Kumar Kedia, in respect of his RTI applications vide ID No. 1122-1141 all dt. 03.09.2015 u/s 19 of the Right to Information Act, 2005. Sh. R.S. Kedia, on behalf of the appellant and Sh. Tanuj Bhanot, PIO/AR (Sec.-6) were present on 05.11.2015.

The appellant in his 20 RTI applications made mention of following letters/ communications:-

Each RTI application, after mentioning above said letters, is followed as under:-

My query is that:-

1. *As per the provisions of the DCS Act 1972, rules, by-laws framed there under, the person acquires the rights of membership when his admission fee and share money has been accepted by the society, which stands received/ accepted by the society on 24.03.1990, by cheque, against my application dt. 24.05.1988 which needs your lawful confirmation under the above Act?*
2. *It is obligatory on the part of the Society to keep one flat reserved for me because my claim was already pending, as on record, and the Society as well as the office of the RCS was throughout conscious of the same which, by nature, is urgent, even now and need your confirmatory reply thereto?*
3. *Under Grievances Redressal Mechanisms of the Hon'ble Prime Minister of India, to analyse Public Grievance to identify policy gaps to upgrade system to classify and track complaints in the right spirit directly by the Secretary Level Officer- the Competent Authority is needed in the service of the imbalance society and also the nation, instead of your non reply under the pretext/ excuse of section 2 (F) of RTI Act and/ or inaction as against my earlier 55 RTI applications, as on record, which must not be repeated now as against my this fresh application which need your detailed reply, in the right spirit thereof?*
4. *May this battle of 'Right' against 'Might', since past 25 years, as on record, is under my Constitutional Rights to get your answers / reply to my letters/ communications, stated above atleast, under RTI Act against this application which may please be provided now, as requested for?*

5. *The needed reply to my above letter/ communication is of supreme national interest to seek the elimination of ground that lead to such an injustice, by your system of delivery of response/ reply cum decision/ justice, as earlier, and inform the present status of the above in the right prospective of the above, at least now?*

During the hearing, the PIO/ AR (Sec.-6) informed that a same reply dated 09.10.2015 on each RTI application has already been given to the appellant. The reply reads as below:-

On careful perusal of RTI application it is observed that the same is in the nature of representation wherein no information/ query has been sought from this department. In view of the same as no information is sought at all, nothing can be provided. You are advised to file a fresh RTI application in conformity with the provisions of RTI Act 2005.

The appellant in his all the 20 RTI application has raised queries with regard to his claim of membership in the Prem Kutir CGHS Ltd. on his said application dt. 24.05.88 to the Society. But the RTI Act does not cover the queries/ interrogative question. The information has been defined under section 2 (f) of RTI Act 2005. Act does not cast obligation to answer queries, as in the case when the appellant attempts to elicit answers to his interrogative texts. Earlier also the appellant filed 55 RTI applications on the same above issue of his membership in the Society. The appellant was then also advised to inspect for himself whichever file of the Prem Kutir CGHS Ltd., he wants information as multiple RTI applications and appeals would not provide him any information beyond the records that exists.

The appeals are accordingly disposed of as dismissed.

As per section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, B- Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
