**ORDER**

This order shall dispose of the appeal filed by Mr. Bharat Bhushan, in respect of his RTI application vide ID No.1253 dated 01.10.2015 u/s 19 of the Right to Information Act, 2005. Mr. Bharat Bhushan, the appellant was present on 14.12.2015. The PIO/AR (Sec.7) or any of his representatives was not present.

The appellant in his RTI application, sought information on various issues pertaining to the affairs of the Sant Tulsi Dass CGHS Ltd., Rohini. The issues mainly relate to demand of Rs. 2500/- raised for white washing, amount spent on 2015 Holi festival, removal of Dhobi out side boundary walls, amount spent on intercom, minutes of the related GBM etc. The information are such which may not be available with the PIO /AR (Sec.7). The PIO/AR (Sec.-7) accordingly forwarded the above RTI application to the Society vide his letter dt. 15.10.15 for furnishing the information directly to appellant. No information has so far been provided by the Society. The PIO/AR (Sec.-7) is directed to pursue it further with the Society, facilitating information to the appellant within a period of 3 weeks from the receipt of this order. Meanwhile, the PIO/AR (Sec.-7) is directed to provide information with regard to details of Show Cause Notices issued by this office to the Tulsi Apartments for the last 3 years as required by the appellant at S.No. 9 of his said RTI application within a period of 3 weeks.

The appeal is disposed of accordingly with the above observations.

As per section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, B- Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
