ORDER

This order shall dispose of 3 appeals filed by Sh. Dharam Pal, in respect of his application vide ID No. 1348 dt. 23.10.2015, 1359 & 1361 dt. 26.10.2015 u/s 19 of the Right to Information Act, 2005. Sh. Dharam Pal, the appellant was present on 17.12.2015. None present for the PIO/AR (Sec.-7).

The appellant in his above RTI applications sought following information:-

ID No. 1348:- Action taken report on his complaint dt. 21.09.2015 against the Managing Committee of the Saya Coop. T/C Society Ltd.

ID No. 1359 :- Certified copies of note sheet processing the action taken by the Deputy Registrar (N/W) against the Society for not filing the returns as directed by the Special Registrar (FAA) vide order dt. 28.03.2014 on his RTI appeal.

ID No. 1361:- Certified copies of note sheet processing the action against the MC of the Society u/s 37 of DCS Act 2003 by the RCS from the beginning and after the issue of order of supersession dated 05.08.2015.


Copies of the letters/correspondence made to the MC of the society u/s 37 of DCS Act 2003.

Reasons of not initiating action against the MC on non-compliance of statutory obligation and non-compliance of the orders of the CS office.

The appellant did not receive any response on any of his above RTI application from the PIO/AR (Sec.-7). The PIO/AR (Sec.-7) is directed to provide information to the appellant on his above 3 RTI applications within a period of 2 weeks from the receipt of this order.

The appeal is disposed of accordingly with the above observations.

As per section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, B- Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
