**ORDER**


This order shall dispose of the appeal dt. 25.06.15 of Ms. Renu Saini against the reply dt. 27.05.15 of the President of the Seema CGHS Ltd., Dwarka in respect of her RTI application dt. 29.04.2015 filed under section 139 of DCS Act 2003. The appellant in person and Sh. K.L.Mehta, President alongwith Dr. Poonam Juneja, Secretary of the said Society were Present on 20.07.2015.

The appellant in her RTI application sought information inter alia pertaining to digging of bore well; common maintenance; employees' details; contract of security services & AMC etc. The President, vide his letter dt. 27.05.15, informed the appellant that under section 139 r/w Rule 165 of DCS Rules 2007, a member can seek information with regard to her own affairs only. The information sought at S.No. 1 to 4, 6 to 10 and 12 to 14 were considered beyond the scope of Rule 165 of the DCS Rules 2007 and were not provided to the appellant. Further, the appellant being a defaulter in the payment of the dues amounting to Rs. 13192 was not entitled to seek information u/s 139 till the dues are cleared, as per the reply of the Society.

Both parties made their points during the hearing. After hearing their contentions, it is gathered that the appellant has been denied information on one pretext or the other. Being a defaulter is not any ground for not providing information to a member as the society has sufficient means under DCS Act/ Rules to deal with the defaulters. Under Rule 165 of DCS Rules 2007, in my opinion, only those information which relates to personal information the disclosure of which would cause unwarranted invasion of the privacy of the other member qualify as the information which the society should not part with otherwise the appellant, being a shareholder of the Society, is entitled to seek any information pertaining to its activities.

The society is therefore, directed to furnish all the information sought by the appellant in her RTI application dt. 29.04.15 except the reasons sought there in information no. 3, 5, 9, 10, 11, and also 14 which too does not come under the category of "information". The President/ Secretary of the Seema CGHS Ltd. shall provide the information, as directed above, to the appellant within a period of two weeks of the receipt of this order.

The appeal is disposed of accordingly with the above observations.
