ORDER

This order shall dispose of appeal at 01.06.15 of Mrs. Pooja Anand against the reply dt. 20.05.15 of the Veer Puru Cooperative Group Housing Society Ltd., Rohini on her RTI application dt. 24.04.15 under section 139 of DCS Act 2003.

In response to notice, hearing took place on 30.07.15, 24.08.15 and 31.08.15. On 31.08.15 the appellant was represented by her husband Sh. Rishi Anand and Sh. B.N. Singh, Vice President was present on behalf of the said Society.

The appellant in her above RTI application required (1) list of court cases lying pending in various courts of Delhi; (2) case wise details of expenditure incurred by the Society since taking over charge of present MC; (3) whether the MC has taken approval of AGM/EGM before filing appeal in the higher courts against orders passed by Arbitrator/RCS office (u/s 91 of DCS Act) and (4) Balance sheets of last 3 years. The Secretary of the said Society vide his letter dt. 20.05.15 informed the appellant "we are sorry we cannot provide you the information sought for under RTI Act since you are not the member of the Society..."

The appellant alongwith her appeal has enclosed documents as per which it is seen that her appeal for membership u/s 91 of DCS Act 2003 was upheld vide order dt. 19.02.14 of the then AR (NW-II), execution of which was upheld by the court of Hon'ble Financial Commissioner in case Revision no. 106/2014.

Further, In Arbitration Award dt. 11.01.2014, the Society was directed to delete name of the appellant (claimant) from the list of defaulters sent to the DCSHFC for initiation of recovery proceeding against her.

All above sufficiently indicate the status of the appellant in the Society for at least getting the information from the Society. The President/ Secretary of the Veer Puru CGHS Ltd. is directed to furnish the information as asked by the appellant in her RTI application dt. 24.04.15. within a period of 3 weeks from the date of hearing i.e 31.08.2015.
