**ORDER**

This order shall dispose of appeal dt. 29.06.15 of Ms. Geeta Narula against the response of the PIO/AR (Sec.-5) on her RTI application filed under RTI Act 2005. The appellant was represented by her counsels Sh. R.C. Beri and Sh. Suresh K. Beri. Sh. B.K. Puri, the PIO/AR (Sec.-5) was present during the hearings.

The appellant in her RTI application vide ID No. 394 dt. 17.04.2015 sought information regarding her application (Form 29) dated 29.06.2011 for execution of Award dated 04.03.2007 of Rs. 51389/- in Arbitration case No. 777/06-07 against the NDSE Cooperative Society Ltd. The PIO/AR (Sec.-5) vide his letter dt. 25.05.2015 replied that her said application for execution of award of Arbitration is not available in Section-5 and was requested to file copies of the said execution and award of arbitration for process the matter further.

An information was sought under RTI Act 2005 by the appellant. The execution of award in arbitration or any other decree is a separate process altogether. Under RTI Act, the PIO is required either to provide the information or reject the request for any of the reasons specified in Section-8 and 9 of RTI Act 2005. The PIO/AR (Sec.-5) is accordingly directed to provide the information as asked in her RTI application dt. 17.04.2015 within a period of two weeks from the receipt of this order free of cost.

The appeal is disposed of accordingly with the above observations.

As per section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, B- Wing, August Kranti Bhawan, Bhikaji Cama Place, New Delhi 110066.
