**ORDER**

This order shall dispose of appeal dt. 03.09.15 of Ms. Veena Sharma against the President/Secretary of the Shivlok CGHS Ltd., Dwarka for refusing her RTI application dt. 30.06.2015 under Section 139 of DCS Act 2003. The Said RTI application was later sent to the Society through speed post received on 02.07.15 as per track record enclosed.

Sh. Naresh Sharma for the appellant and Sh. Likhil Nagar for the Society were present on 29.09.15 and 06.10.15.

The appellant in her RTI application inter alia sought details of contractor who carried out the repair work in the society, details of the caterer engaged for arranging lunch/ snacks organised on all the major events; the copy of electricity bills of BSES and the billing cycle details of payment collected from each flat and deposited to the BSES etc. During the appeal the representative of the society filed a response to the appeal notice in which it is stated that the society does not fall within the parameters settled under section 2 (h) of the Right to Information Act 2005. Further, if directed, they (the society) will provide any kind of information.

The present RTI application has been filed under section 139 of DCS Act 2003, not under the RTI Act 2005, the Society is statutorily under obligation to follow all the provisions of DCS Act/Rules in letter & spirit. The president/ Secretary, is therefore directed to provide the information sought by the appellant in her above RTI application within a period of 4 weeks of receipt of this order on payment of prescribed fee in respect of documents sought. The information will be provided for the last five years only as per provision of Rule 165 (4) (d) of DCS Rules 2007.

The appeal is disposed of accordingly with the above observations.
