ORDER

This order shall dispose of the appeal filed by Shri K.L. Verma, Appellant in respect of his application dated 24.08.15 ID No. 843 dt.26.06.15 U/s 19 of the Right to Information Act, 2005. None was present during the hearing on 15.09.2015.

The appellant in his appeal has submitted that he has not received the requisite information on point No.01 & 06 of his RTI application from PIO (Audit Branch) and on point No. 02 & 03 for which PIO (Section-IV) has responded on 21.07.15 by giving the reply that "No such information is available/pertains to society." He has also requested for correct information on point no. 04 & 05 from PIO (Section-IV).

After going through the RTI application, reply given by PIO (Section-IV) and appeal filed by the appellant, the PIO (Audit) is hereby directed to give the required information i.e. copy of Audit Report of Mitra Deep CGHS Ltd. for the financial year 2013-14 and copy of order of appointment of the Auditor for audit of accounts of the Mitra Deep CGHS Ltd. for the financial year 2010-11 to 2013-14, to the appellant within two weeks of issue of this order. **(Copy of RTI application ID No.843 is enclosed).** As regard point No. 02 & 03, such type of information are not maintained/kept in this office. The appellant may seek these information from the society under provisions of section 139 of DCS Act, 2003 read with Rule 165 of DCS Rules, 2007. As regard information sought on point no. 04 & 05, PIO (Section-IV) is hereby directed to give the present status on appellant's petition within two weeks of issue of this order.

The appeal is disposed off accordingly.

As per Section 19 of the Right to Information Act, 2005, the appellant may file an appeal, if any, within 90 days of the issue of this order before Second Appellate Authority i.e. Central Information Commission, August Kranti Bhawan, Bhikaji Kama Place, New Delhi.
