Sub:- Appointment of Returning Officer for conducting election of Managing Committee of VAISH COOPERATIVE NEW BANK LTD, 7B, Netaji Subhash Marg, New Delhi

Whereas the Vaish Cooperative New Bank Ltd, 7B, Netaji Subhash Marg, New Delhi is registered at Sl. No- 57B - BANK with this Department under the provisions of DCS Act and Rules and Bye-Laws of the Bank.

Whereas the last election of the Managing Committee of the Vaish Cooperative New Bank Ltd was held on 04.09.2011. The terms of office of the elected members of the committee shall be three year as per provisions of Section 35(3) of the DCS Act 2003.
